STEP II - Reason for Appeal Grievance regarding the mislabeling and misdelivery of mail. Said mail to the grievant by the mail room is grievable in accordance with PD 03.02.130 (G), which M. McLean, grievance coordinator, seems to be unfamiliar with as demonstrated by this baseless reflection. As such, M. McLean has violated state law by failing to be familiar with rules and policies, MCL 19.142, Failing to perform his duty, MCL 750.478, and conspiracy to cover up state and federal law violations by mail room employees at URF constituting obstruction of justice, misprison and misconduct in office, MCL 750.505 in concern of the interference with grievant's USPS mail in violation of 18 USC 351702, 1703, as well as grievant's civil rights in violation of 18 USC 35241, 242. Wherefore, remedy demanded at steps I & II must be granted and warden Horton investigated, charged and prosecuted for failing to comply with MCL 19.142, MCL 750.478 and MCL 750.505 and her attendant engagement in a conspiracy to violate federal law and grievant's civil rights in violation of 18 USC 35241 & 242.

On 1/05/18 grievant received two (2) CURE (National) newsletters in envelopes provided by mail room staff at URF addressed to him as "Gould 187131F11" (sic), later corrected by an unknown party, likely F-Unit C/O, to "B-176." As Grievant only gets one (1) issue at a time of said newsletter, it is more than likely the other copy was the U.S.P.S. mail of another prisoner. This error, or errors, are the direct result of the violation of 18 USC §§ 1702, 1703 unlawfully mandated by PD 05.03.118 and is, in essence, the theft of ~~the~~ USPS mail, namely the envelopes. As such this illegal mail policy should be rescinded and all MDOC employees involved in its promulgation and effecting its mandates should be investigated and prosecuted to the fullest extent of the law.
